- 1.4 Our Privacy Policy and the Cookie Policy also apply to your use of our Website.
- 1.5 You are also responsible for ensuring that all persons who access our Website through your internet connection are aware of these Terms of Use, the Privacy Policy and the Cookie Policy, and that they comply with them.

2 Definitions and interpretation

9 Viruses
